

Privacy Policy

Your privacy is critically important to us. At Signature Transaction Management, LLC we have a few fundamental principles:

- We don't ask you for personal information unless we truly need it.
- We don't share your personal information with anyone except to comply with the law, develop our products, or protect our rights.
- We don't store personal information on our servers unless required for the on-going operation of one of our services.

Below is our privacy policy which incorporates these goals:

Signature Transaction Management, LLC Inc. operates two websites including SignatureTransaction.com and SignatureTransactions.com. It is Signature Transaction Management, LLC's policy to respect your privacy regarding any information we may collect while operating our websites.

Website Visitors

Like most website operators, Signature Transaction Management, LLC collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. Signature Transaction Management, LLC's purpose in collecting non-personally identifying information is to better understand how Signature Transaction Management, LLC's visitors use its website. From time to time, Signature Transaction Management, LLC may release non-personally-identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its website.

Signature Transaction Management, LLC also collects potentially personally-identifying information like Internet Protocol (IP) addresses. Signature Transaction Management, LLC does not use such information to identify its visitors, however, and does not disclose such information, other than under the same circumstances that it uses and discloses personally-identifying information, as described below.

Gathering of Personally-Identifying Information

Certain visitors to Signature Transaction Management, LLC's websites choose to interact with Signature Transaction Management, LLC in ways that require Signature Transaction Management, LLC to gather personally-identifying information. The amount and type of information that Signature Transaction Management, LLC gathers depends on the nature of the interaction. Signature Transaction Management, LLC does not disclose personally-identifying information other than as described below. And visitors can always refuse to supply personally-identifying information, with the caveat that it may prevent them from engaging in certain website-related activities.

Aggregated Statistics

Signature Transaction Management, LLC may collect statistics about the behavior of visitors to its websites. Signature Transaction Management, LLC may display this information publicly or provide it to others. However, Signature Transaction Management, LLC does not disclose personally-identifying information other than as described below.

Protection of Certain Personally-Identifying Information

Signature Transaction Management, LLC discloses potentially personally-identifying and personally-identifying information only to those of its employees, contractors and affiliated organizations that (i) need to know that information in order to process it on Signature Transaction Management, LLC's behalf or to provide services available at Signature Transaction Management, LLC's websites, and (ii) that have agreed not to disclose it to others. Signature Transaction Management, LLC will not rent or sell potentially personally-identifying and personally-identifying information to anyone. Other than to its employees, contractors and affiliated organizations, as described above, Signature Transaction Management, LLC discloses potentially personally-identifying and personally-identifying information only when required to do so by law, or when Signature Transaction Management, LLC believes in good faith that disclosure is reasonably necessary to protect the property or rights of Signature Transaction Management, LLC, third parties or the public at large. If you are a registered user of a Signature Transaction Management, LLC website and have supplied your email address, Signature Transaction Management, LLC may occasionally send you an email to tell you about new features, solicit your feedback, or just keep you up to date with what's going on with Signature Transaction Management, LLC. If you send us a request (for example via a support email or via one of our feedback mechanisms), we reserve the right to publish it in order to help us clarify or respond to your request or to help us support other users. Signature Transaction Management, LLC takes all measures reasonably necessary to protect against the unauthorized access, use, alteration or destruction of potentially personally-identifying and personally-identifying information.

Cookies

A cookie is a string of information that a website stores on a visitor's computer, and that the visitor's browser provides to the website each time the visitor returns. Signature Transaction Management, LLC uses cookies to help Signature Transaction Management, LLC identify and track visitors, their usage of Signature Transaction Management, LLC website, and their website access preferences. Signature Transaction Management, LLC visitors who do not wish to have cookies placed on their computers should set their browsers to refuse cookies before using Signature Transaction Management, LLC's websites, with the drawback that certain features of Signature Transaction Management, LLC's websites may not function properly without the aid of cookies.
